

**MINUTES OF MEETING OF TOWN COUNCIL  
TOWN OF BREMEN, INDIANA  
November 22, 2021**

The Town Council of the Town of Bremen, Indiana, met in regular session at 4:30 p.m. on Monday, November 22, 2021, at the Bremen Town Hall pursuant to notice previously published. Council members James Leeper, Mike Leman, Rick Graverson, and William Daily were present. Also present were Chief Brad Kile, Police Department; Austin Langdon, Superintendent of the Street Department; Chief Matt Neher, Fire Department; Matt Cunningham, Superintendent of the Wastewater Department; Keith Fraine, Cemetery Sexton; Ken Jones, Town Engineer; Janet Anglemyer, Clerk-Treasurer; and Anthony Wagner, Town Attorney.

**MINUTES:** Mr. Leman made a motion to approve the minutes of the November 8, 2021 meeting, which was seconded by Mr. Graverson and carried by a vote of 4 ayes, 0 nays.

**CLERK-TREASURER:** Ms. Anglemyer submitted the docket of claims without amendment; Mr. Leman made a motion to approve the docket as submitted, which was seconded Mr. Graverson and carried by a vote of 4 ayes, 0 nays. Ms. Anglemyer asked the Council to set the final meeting date for 2021, and the Council agreed to leave the hearing set for December 27, 2021. Ms. Anglemyer then submitted a request to approve 10 more vacation days to be awarded at the annual awards banquet. Mr. Daily made a motion to approve the award of 10 additional vacation days, which was seconded by Mr. Leman and carried by a vote of 4 ayes, 0 nays.

**TOWN ATTORNEY:** Mr. Wagner had no new information to report.

**PUBLIC COMMENTS:** Barb Sautter thanked the Town employees who had set up the Christmas decorations and asked whether lights would be added to the trees downtown. Mr. Leman suggested that Mr. Stoneburner, Mr. Main, and Mr. Weldy provide that information at the next meeting as they would each be aware of any such plans.

**DEPARTMENT HEAD REPORTS:**

Chief Kile had no new information to report on behalf of the Police Department.

Chief Neher had no new information to report on behalf of the Fire Department.

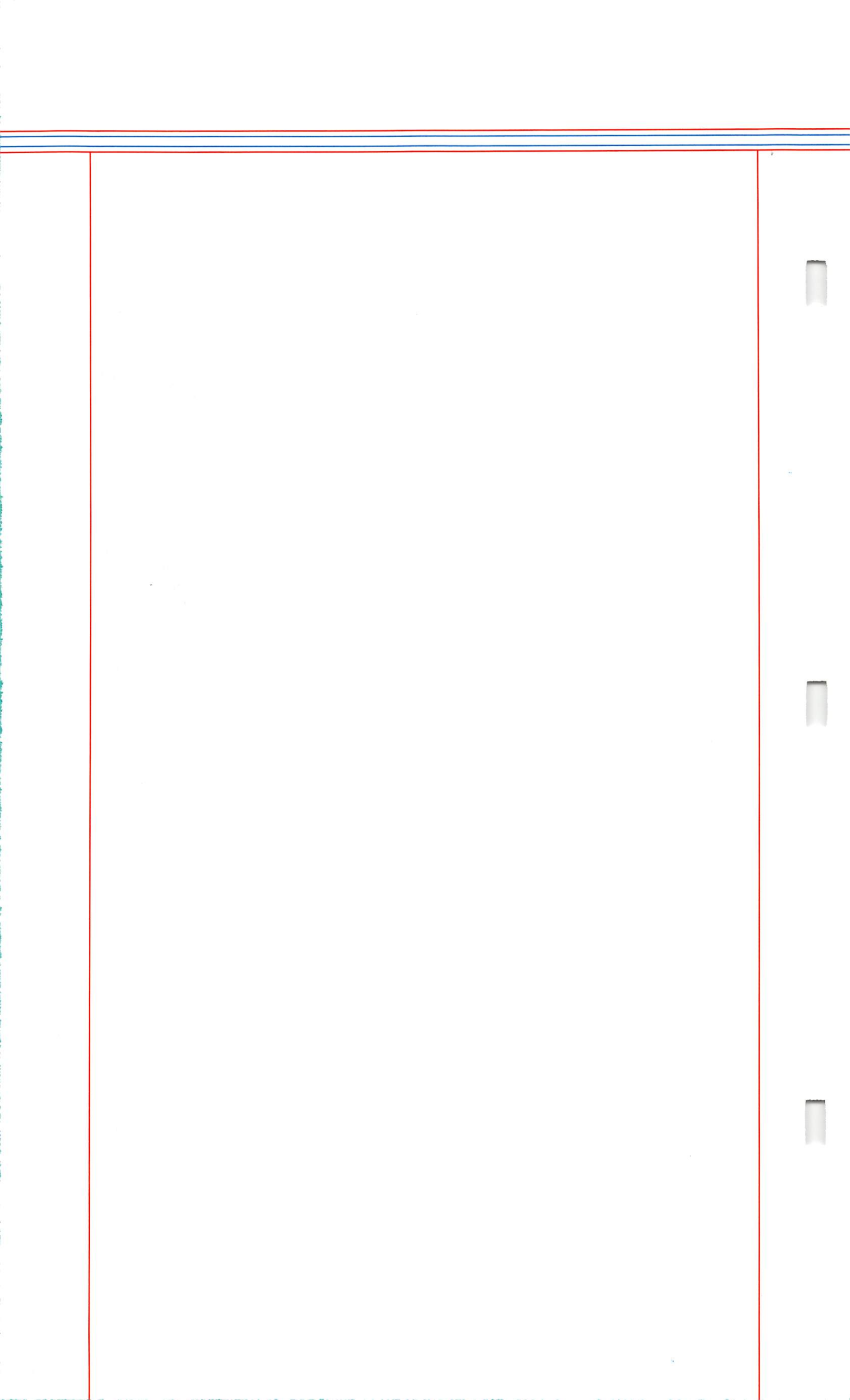
Mr. Langdon had no new information to report on behalf of Street Department.

Mr. Cunningham submitted a request to the Council for the appointment to the Lake of the Woods Regional Sewer District Board. Mr. Leman made a motion to approve the appointment, which was seconded by Mr. Graverson and carried by a vote of 4 ayes, 0 nays. Mr. Cunningham also submitted a new three-year testing and operation contract for the Lake of the Woods sewer system and noted that he had adjusted the pricing from the prior contract. Mr. Leman made a motion to approve the contract, which was seconded by Mr. Daily and carried by a vote of 4 ayes, 0 nays.

Mr. Leman made a motion to approve the Department Head Reports, which was seconded by Mr. Graverson and carried by a vote of 4 ayes, 0 nays.


**TOWN ENGINEER:** Mr. Jones submitted his report.




**COUNCIL COMMENTS:** Mr. Leman discussed the status of the inquiry regarding snake ownership from the previous meeting.
